with a focus in Finance in 2012. Winter served as a Seasonal Clubhouse Assistant from May 1999 - July 2000 at Highland Springs Golf Course. In 2004 he became Athletics Coordinator for the Urbana Park District, a position he held until March 2007. Todd then returned to Rock Island as Sports & Recreation Manager for the City of Rock Island and held that position until March of 2013 when he was promoted to Golf Services Manager for the City of Rock Island overseeing all operations of Rock Island's two municipal golf courses including staffing, budgeting, and purchasing. He had responsibility for planning and implementing an efficient business model in which to operate golf services for the department. He managed and trained a staff of clubhouse attendants, learning program providers, course rangers, and driving range attendants. He worked closely with Golf Maintenance Superintendent to ensure courses maintain high quality. Todd also created and implemented programs and events for the golf courses including outings, leagues, and comprehensive learning programs. This past June Todd was promoted to Assistant Director of the Parks and Recreation Department where he, along with new Park Department Director, John Gripp, undertook the task of reorganizing the Department. Their efforts have so far resulted in a savings of \$300,000 in salaries and benefits from consolidation of duties and elimination of some staff positions. They also initiated a complete review of all Rock Island Parks analyzing costs and maintenance needs. They held a series of community meetings seeing citizen input on the use and opinion of park facilities and programs and the hopes and expectations of the community for future park use and development. Ultimately the discussions lead to identifying parks by "type". Type 1 are the highly visible and high maintenance parks such as Schwiebert and Longview Parks. This type of park is capable of hosting special events and generating income. Type 2 are the typical parks with playground equipment and picnic facilities. They require less maintenance and the primary concern is keeping the equipment and facilities in good shape and safe. Type 3 parks are the open space, natural areas requiring only basic mowing and trimming. Once categorized the Department was able to develop a comprehensive maintenance plan utilizing both municipal and privately contracted maintenance. The goal is to improve efficiency and cost savings while maintaining high quality facilities and programs. Winters also noted that partnerships have been developed with groups such as Rock Island Girls Softball and Friends of Hauberg, and numerous others, where some maintenance and improve costs are shared. He stated that such partnerships have been critical to the goal of providing facilities and programs while staying within a limited budget. Lastly Mr. Winter stated that the Department is currently in a reviewing process where all facilities and programs are being analyzed, Including the revenue generating facilities (Saukie and Highland Springs Golf Courses, Whitewater Junction, and the Fitness and Activity Center. The review includes all special events and all recreational programing. The review involves looking at costs, participation, use of facilities, and determining what programs should be kept, what new programs should be added, and what if any changes can be made to improve facilities and programs within the Department's budget capabilities. Mr. Winter's program was well presented and well received! Thanks, Todd for a thorough update on our Parks and Recreation programs.

## **50 Things Every Rotarian Should Know About Rotary**

#### 16 - TOLERANCE OF DIFFERENCES

Occasionally there is a temptation to criticize the laws, customs and traditions of another country which may seem strange or contrary to our own. In some instances, illegal practices or customs of one nation are completely lawful and acceptable in another.

As members of an international organization dedicated to world understanding and peace, it behoves Rotarians to exercise restraint in judging our Rotary friends and citizens from other countries when their behavior seems unusual to us. A Rotary policy has existed for more than half a century relating to this dilemma of international relationships. The statement, adopted in 1933, says that because it is recognized that some activities and local customs may be legal and customary in some countries and not in others, Rotarians should be guided by this admonition of tolerance:

"Rotarians in all countries should recognize these facts and there should be a thoughtful avoidance of criticism of the laws and customs of one country by the Rotarians of another country."

The policy also cautions against "any effort on the part of Rotarians of one country to interfere with the laws or customs of another country."

As we strive to strengthen the bonds of understanding, goodwill and friendship, these policies still provide good advice and guidance.

#### **Foundation Minute**

Saginaw Street, paved with 116-year-old bricks and lined with restaurants, runs through the heart of downtown Flint, Mich. Around the corner you'll find a farmer's market, a row of museums, a craft brewery, and three campuses: In many ways, Flint fits right in with other quaint and trendy towns in America.

But while parts of the city are experiencing a renaissance, 40 percent of Flint residents live below the poverty line. And although the murder rate dropped nearly in half between 2013 and 2014, there were still 48 homicides in 2015 (in a city of fewer than 100,000 people). Then, two years ago, news broke that lead was leaching into the city's water.

Two pediatricians were instrumental in pushing the city and state governments to admit that the lead problem was real and then in leading the cleanup efforts. One of them is Amy Krug, 2015-16 President of the Rotary Club of Flint. Donations have come from various Rotary clubs including one in Dexter, Michigan, which had its own disaster in 2012 when a tornado ripped through its town and another from Nashville, Tennessee whose club president traveled to Flint to present the funds in person. "Rotary and other local organizations," states Flint Rotarian Jamie Gaskin who heads the United Way of Genesee County, "took donations giving grants to services that will support those in need ensuring accountability."

Gaskin states, "Rotary represents a group of thoughtful folks who already understood water in a lot of different ways. "Although until this crisis hit Flint, members of his club had always talked about water issues happening somewhere else, never in their own community. As the data revealed the severity of the problem, Rotarians in churches, civic organizations and professions began to encourage all those institutions to respond.

This is another example how Rotarians once again join together to use their skills and passion to make a difference in their community and the world. We should be proud to be a Rotarian.
