Rock Island Rotary entered our 104th year under the leadership of Bruce Peterson, the 102nd Rotarian to hold the position as Rock Island club president (two held the office for two terms, Emerson Fisher, 1917-19 and Jeff Dismer, 2006-08). Bruce began his comments by thanking his wife, Sue, for her support and encouragement and thanking the club for giving him the opportunity to serve as president. He then spoke of the loss suffered by the club with

the untimely death of member. Chuck Austin. The balance of his talk centered on the upcoming year. He began by reminding us of the phrase, "The Power of One", noting that one dedicated and hard working person has great power. He then said for Rotary, multiply the power of One by 1.3 million. He then reviewed how much Rotary International has done for the world, particularly in the battle to end Polio. He noted that along with the Gates Foundation, Rotary has rid the world of the deadly disease in all but two countries; and the battle there continues. On the local scene President Bruce set a goal to build our Augustana Scholarship Endowment to \$20,000 so that a meaningful scholarship can be given each year from the earnings. Currently the endowment has a balance of \$7,000 and will soon be increased with club funds to \$10,000. He asked club members to consider making a contribution during the coming year. He expressed continued support for our Earl Hanson Partnership including the Birthday Book program, the Pumpkin Patch field trip, and the Angel Tree Christmas donation program. He noted that Fred Luckenbill will continue our Dining Book fundraiser and noted that last year \$1,000 was raised. Bruce said that our Trivia Night fundraiser will be held on November 11th and he encourages all Rotarians to participate. In December he said our Rotary Ramble 5K Run will be one of our major fundraising events of the year and asked that all members help in one way or another. December will also see us continue helping the Salvation Army by manning the kettle and ringing the bells. Presendent Peterson then announced that our club has successfully obtained a Rotary District grant which will support the Youth Hope Creative Arts program. Bruce invited Rotarians to sit in on practice performances of the student poets to offer support and encouragment. Continuing his summary of upcoming events the president urged continued support for the Heart of Hope Food Pantry by donating plastic grocery bags and manning the Pantry on Thursday nights. Continuing our efforts in Literacy, Bruce announced that 10 mini libraries have been build and will be needing paint and a stock of books prior to their placement at Rock Island schools and community sites. He noted that our club will continue hosting Jr. Rotarians from Rock Island and Alleman High Schools and reminded members that these student leaders are also the future of Rotary. He thanked our members for always making the students feel welcome and included in members' conversations. Bruce stated that the club will again host the "A Little Off Key" fundraiser in March and urged members to He pledged support for coninuing the Entrepreneur & Enterprise program at Rock Island High School. He said the club will also continue honoring our community's finest with our annual Award Banquet; and our Budget Priorities Committee will continue financial support of local projects and organizations with a \$7,500 budget for next year. He noted that our strong backing of the Birdies for Charity program will help continue the growth of our local club foundation. In conclusion president Bruce reminded us that Rotary is not a spectator sport! We all must do our part to ensure the continued success of our club! It appears our club is in good hands for the coming year! Best of luck to President Bruce and the new Board of Directors.

Rock Island Rotary made a \$400 donation to Dress For Success Quad Cities. The purpose of Dress For Success is to offer long-lasting solutions that enable women to break the cycle of poverty. Dress for Success is part of a global movement for change, empowering women to obtain safer and better futures. They provide each client with professional attire to secure employment, but are about much more than simply a new outfit. Besides physically equipping the client with apparel and accessories. The program furnishes the client with a confidence that she carries forever and the knowledge that she can actively define her life, the direction she takes and what success means to her. Dress for Success is a stepping stone forward for many women who, for a variety of reasons, have not reached their full potential. They help women dress professionally, develop or



improve the skills associated with life and career success, and encourage them to pursue careers that fulfill them. Volunteer staff work with clients to help choose an interview outfit and also provide guidance and support for the upcoming interview. The program includes help for remaining employed, and provide strategies to nurture professional growth. They also address and strive to eliminate the frustrating obstacles that may arise during a search for employment. Dress For Success also host a "Career Center" where women meet regularly to support and encourage each other through building confidence, networking and discussing workplace-related topics. These meetings help participants stay motivated and optimistic.

48 - About Community Service'

A community, defined in its simplest terms, is a group of people who have something in common. But in real life, it is something far more complex than that. Each member — every individual, group, organization, and business — draws benefits from the community in many ways. For a community to thrive, each of its members must honor a commitment to contribute to the well-being of the whole by returning those benefits in kind.'

Rotarians recognize the importance of giving back to the community. After all, Community Service is one of the Four Avenues of Service. Every Rotary club and every Rotarian assumes a responsibility to find ways to improve the quality of life for those in their communities and to serve the public interest. When those efforts are effective, they not only contribute to the greater good, they also promote Rotary's positive image.

What makes a community service effort effective? Relevance. A community service project must address a real, current community concern or issue. Rotary clubs should start by surveying their communities to find out where help is needed. Once a club has listened to its community, it can begin to envision effective responses to problems.
