# AVOID THAT SCAM!

Today Chris Coleman, President of the Better Business Bureau serving Iowa and Illinois, and Sandra Bowden of the Bettendorf BBB Office visited Rock Island Rotary. Mr. Coleman spoke about the Better Businees Bureau and also provided tips to help avoid holiday season scams. He noted that the Better Business Bureau was formed in the early 1900s subsequent to the enactment of the first U.S. law regulating fair trade and food and drug advertising. companies to face charges for violating fair advertising regulations. The BBB ws created to promote self regulation and transparency in business marketing. BBB coaches businesses on ethical behavior and how to build stronger, more trusting relationships with their customers. BBB offers its national and local consumer services online and in person. The BBB helps millions of people each year. With regard to scams, Mr. Coleman said that scams can be divided into two categories: 1) Advanced Fee Scams; and 2) Rogue Local Scam Artists. Advanced Fee scams typically offer something of value but ask that the consumer send money to obtain the "prize". Examples of such scams are vacation rentals, asking for a deposit or "small" fee for the vacation; IRS scams claiming taxes are owed and must be paid immediately or an arrest warrant will be issues; Cruise trips asking for taxes and port fees in exchange for the luxury cruise; and a loved one in jail or injured and money is immediately needed to prevent further harm. These are cruel scams, and nothing is received by the consumer once they send their money. Examples of Local Scam Artists are sales of advertising on sports or school calendars or posters where once the money is paid the calendar/poster is never produced; coupon book ad sales where once the merchant pays for the ad, the coupon book is never produced; and, contractors who take money up front and then don't perform the work. Rotarians were left with several helpful handouts identifying more scams and giving tips to protect one's identity. Thank you, BBB for your hard work and an interesting and valuable program.
