the areas of business start-up, expansion, acquisition and sale. She also assists with business planning, marketing, record keeping and financial analysis. In addition to one-on-one counseling, she presents education and training at the request of organizations and small businesses. When introducing her in June of 2017, Jim Boyd, WIU's SBDC Director said "We're pleased to have Ann join our team at the Illinois SBDC-ITC at WIU-QC". "With her extensive contacts in the Quad Cities community, she'll be able to assist small businesses with their start-up and growth plans. She comes with a wealth of experience, not only in the private sector, but the public sector as well. With the addition of Ann to our staff, we look forward to the Illinois SBDC-ITC being an integral part of the small-business landscape in the Quad Cities and surrounding Illinois counties." Ms. Fredrichs noted that the SBDC serves many functions for Illinois small businesses including: 1) Help Starting A Business with feasibility studies; Assessment of the clients ability to ge into business; Business plans; Help with financing applications; and help with improving the client's credit. 2) Helping Business Growth with assistance in identifying new markets and new products; Help with long term planning; Help with exporting; and Help with procurement of government contracts. 3) Help Businesses Sustain, which includes: Analysis of processes for improvement; Marketing plans; Cost and pricing assistance; and Continuing education classes and seminars. 4) Help with Succession Planning, which includes: Reviewing personal and financial considerations; Identifying opporutunities for selling the business; Assistance in valuation of the business; and Readiness planning for exiting the business. The SBDC is also active with the Mercado Project which specifically directs help to hispanic owned businesses. They also facilitate a "Fast Pitch Contest" which allows entrepreneurs an opportunity to "pitch" their business ideas to investors. Winners receive \$3,500 cash and \$35,000 in newspaper and media advertising. Another area served by Ms. Frederich's agency is minority businesses through a Minority Empowerment Equipment Grant Program, which provides \$1,000 grants to minority owned businesses for the purchase or repair of equipment used in the business. Lastly, Ms. Frederich noted that her office offers a seminar entitled "Starting A Business in Illinois" which is open to any citizen and offered at the Western Illinois University Quad City Campus.
