

HEALTH CARE REFORM

Dr. Christopher Peters grew up in Kansas, earned his medical degree at the University of Kansas, and served nine years as an officer in the U.S. Army Medical Corps. Now a resident of Coralville, Iowa, with his wife and three sons, Dr. Peters is in priivate practice with a specialty in thorasic surgery. He is a veteran, a doctor, and a small business owner. Today he spoke to us on the topic of a Common Sense Health Care Reform.



Dr. Peters noted that Americans spend far more per capita on healthcare than any other developed nation, and total healthcare spending in

America now exceeds 17 percent of GDP. Peters said he believes we need to reintroduce free market principles into the healthcare field, and that we can do so while still providing support to those who need it. Out-of-pocket expenses account for less than one-fourth of private healthcare spending in the U.S. That dynamic drives one of our underlying issues – our healthcare system does not reflect a true free market. Americans have very little information about the costs of their care and as a result patients seldom "shop around," even though most health care is elective, and not for treatment of emergencies. As a result, neither patients nor providers have much incentive to control costs. We should return to a traditional insurance model for healthcare, which would provide coverage for unexpected but potential calamitous illness or injuries. This is best accomplished through what is also known as catastrophic health care insurance. Such insurance policies have much lower premium costs, making them more affordable to all Americans, and reducing the need to subsidize such costs. In other areas of our lives we purchase insurance policies to mitigate the risk of unlikely and costly events, but we do not use that insurance to cover routine needs. For example, while automobile insurance will cover a serious collision, and home insurance will cover a fire, we do not expect those insurance policies to cover an oil change or housecleaning. Peters also is a strong proponent of Health Savings Accounts (HSAs). Routine healthcare needs - with the exception of unexpected and catastrophic events, which would be covered by insurance - should be paid for by individual patients. This would eliminate the middleman costs of insurance companies, as well as allow market forces to work in a myriad of ways. It would promote price transparency by providers, while also promoting cost transparency to consumers, who are currently largely unconcerned with costs of healthcare services. It should thereby reduce the costs of individual medical services, decrease unnecessary utilization of healthcare services, and hopefully also promote healthier lifestyles. Dr Peters stated that health care costs in the United States have increased 8 times more than similar costs in other G-7 nations. He said administrative costs eat up 15 to 30% of health care spending and that thired party (insurance companies) payments for most services have led to over utilization of services by both patients and providers. Stimply stated, people don't care what the cost is, so long as insurance covers it. In summary Peters suggested that the long term solution to our health care crisis is reforming health insurance by encouraging high deductables leaving routine costs to market pressure; encouraging health savings plans; revise intellectual property right laws (patents) to ensure that the benefits given to pharmaceutical companies do not outweight the cost incurred by patients. Foundation Minute

The Rotary Foundation transforms your gifts into service projects that change lives both close to home and around the world. Many of these projects are directed towards conflict and violence that has displaced millions of people each year. Half of those killed in conflict are children, and 90% are civilians.

Rotary refuses to accept conflict as a way of life. Its projects provide training that fosters understanding and provides communities with the skills to resolve conflicts.

In the past Rotary and its members have helped Tanzanians with albinism find safe futures. It helped a university professor and a Rotary club fight Boko Haram by helping those women who were kidnapped find a new life. It has helped Brazil's youth escape from slums by offering them judo and helped end domestic violence in Australia.

A Rotaract club in the Philippines conduct anti-bullying campaigns in schools to teach children how to handle conflict peacefully from an early age, and local Rotarians in Louisiana dealt with domestic violence – the fourth highest incidence of death in the US -by helping a shelter provide food, clothing, legal advocacy and counseling to over 500 women in one year.
