Guest speaker at today's Rock Island Rotary meeting was Ben Leischner, entering his third month as Executive Director of the Quad City International Airport. He was selected from a pool of 37 applicants for the job. "I am very excited to join the Metropolitan Airport Authority of Rock Island County and to partner with the Board in the continued success of Quad City International Airport," said Mr. Leischner. "I am very impressed by the people and the community the airport serves and I look forward to partnering with



local leaders in pursuing regional initiatives that increase services for the community." Leischner spent the past 14 years working for the Seattle-Tacoma International Airport. He earned a Bachelor of Science in Aviation Management and Flight Operations from Florida Institute of Technology and a Masters of Public Administration from the University of Nebraska. Mr. Leischner is an Accredited Airport Executive (A.A.E.) from the American Association of Airport Executives and is a commercial instrument pilot. He and his wife, two daughters, and a son on the way purchased a home in Milan and his girls are attending Jefferson Elementary School. Leischner said his move to the Quad Cities was spurred by a desire to have more community involvement and time for family. In Seattle his commute was 2 hours daily and he noted that there is really no "community" atmosphere in a big city. He thought the Quad Cities is a "right sized community". He characterized it as, "Small enough to be five minutes from everything and big enough to get lost in." The Quad City Airport faces a number of challenges when it comes to funding and keeping passengers in the Quad Cities as opposed to flying tout of Chicago. He said the challenge is to make it profitable for airlines to fly out of the Quad Cities. He said our airport "overhead" costs for the airlines is about \$10 per passenger. An airport of our size should have costs at \$2-\$4 Leischner said. Bringing in more revenue and controlling costs are on his priority list. He said cutting costs and bringing in revenue go hand in hand. For instance vacant space in the airport terminal and grounds "costs" the Airport Authority. If they can fill vacant space and make use of airport property, the income generated offsets costs so fees charged the airline companies can be reduced. Leischner also spoke of bringing new airlines to the Quad City International Airport. He says he would love to see more airlines and more service out of the Quad Cities again noting that it must be profitable for the companies. He said that Southwest Airlines has contacted him about possibly coming to the airport in the future, but nothing has been talked about seriously as of yet. United, American, Delta, and Allegiant are the four airlines that fly out of the Quad Cities. He said they provide good service and connect with hubs that allow Quad City passengers to go just about anywhere with one stop. He said he would love to see service to Seattle which is the major hub for travel to Asia. Currently Quad City Travelers can fly direct to Chicago, Atlanta, Detroit, Phoenix, Las Vegas, Minneapolis, Denver, Dallas, Orlando, St. Petersburg, and Ft. Myers. When asked where the Airport gets it's funding Mr. Leischner stated that tases are a relatively small part of their budget. Most income comes from userfees from the airlines, land leases, and concession/vendors in the airport terminal. Ben Leischner appears to be an outstanding choice to head up the Quad City International Airport and will provide strong leadership for future growth and great customer service.

Foundation Minute

Ricardo Roman was shopping with his wife at a department store in Chile in 2012 when a woman in her early 20s approached him. He didn't recognize her – for two good reasons – he had last seen her more than a decade earlier and her smile had changed drastically!

Roman, a member of the Rotary Club of Renaca, Chile, is the national coordinator of a program that has helped thousands of children in Chile with cleft lips, palates, and other birth defects – including this stranger who now wanted to give Roman a hug.

She told me, "This is my Rotarian smile," Roman recalls, his voice full of emotion, "It was a very gratifying moment."

Since 1993 Rotarians in Chile and the United States have teamed up to provide life-altering reconstructive surgeries. The project was started by California Rotarians and has evolved into a nonprofit organization that has since sent teams to 26 countries.

DUNCAN CAMERON IS THE FIRST IN THE "SPOTLIGHT"

Today we had our first 5-Minute Spotlight presentation by Duncan Cameron who told us of his adventures at the Major League Baseball All Star Games. Proceeds of the first game in 1933 were donated to the Tribune Children's Charities. Duncan noted the parallel of both Rotary and the All-Star game being born in Chicago and both aimed at service and charitable work. Duncan has gone to every All Star game since 1983, that game was held in Chicago at Comiskey Park (now a parking lot for the new stadium) Duncan also noted how the event has grown from the first game to the current game which now includes five days of activities including the "Futures Game" which previews minor league stars, the Commissioners Party, the Home Run Derby, a Pre-Game Party, a Fan fest with vendors of baseball equipment and memorabilia, and ending with the All Star Game.
