# COVID 19 Allison Wright looks at the Legal Issues

Allison is a partner in the law firm of Pappas, Wright & Wright, P.C. Allison received her BA With Highest Honors from the University of Illinois and her J.D. With Distinction from the University of lowa Law School. She is admitted to practice in Illinois and lowa and in the U.S. District Court for the Central District of Illinois. Her legal practice centers on

Labor & Employment Law representing management. .Her program today concentrated on legal issues facing businesses as a result of the corona virus pandemic. She divided her comments into three main areas, The Federal Opening Up America Guidelines, Governor Pritzker's Restore Illinois Plan, and Business Practices recommended for her clients. Attorney Wright explained that although the Federal "Guidelines" seem to be voluntary recommendations, they are backed by the CDC and OSHA. One of the major parts of the federal plan was requiring employers to provide paid leave for employees laid off or

furloughed because of the virus. The federal guidelines also set standards for Social Distancing, and provided direction regarding checking temperatures of employees and others who enter the workplace; sanitation standards including disinfecting common and high traffic areas, standards for testing, isolating and contact tracing, and guidelines for business travel. Wright stated that business should have written policies in place for each area. With regard to Illinois rules, the governor has divided the state into regions and laid out a 5-phase plan for reopening the state. Our area lies in the North Central Region which also includes Dekalb and Peoria. Pritzker stated that phase 1 is the time of rapid spread; phase 2 occurs when the spread flattens; phase 3 is the recovery period, phase 4 is revitalization, and the final phase is called "Illinois restored". Presently all regions of the state are in phase two and will remain in that phase through at least May 29th. . In phase 3 manufacturing, offices, retail, barbershops, and salons can reopen to the public with capacity and other limits and safety precautions. Gatherings of up to 10 people will be allowed. In phase 4 (Revitalization): Gatherings of up to 50 people are allowed, restaurants and bars reopen under safety guidance from IDPH, and childcare and schools reopen under guidance from IDPH. Phase 5 is essentially a return to normal;, but, will not occur until such time as a vaccine is widely available and utilized.. The Illinois plan will be a slow recovery. Restore Illinois requires a region to experience a downward trend in test positivity rates for 14 days, a downward trend in hospitalizations for COVID-like illness for 28 days, and a specific hospital surge capacity. If a region is able to meet those metrics outlined by public health experts, they can move to the next phase. In essence a minimum of a month is required at best to move from one phase to another. In the area of recommended business practice, Ms. Wright, states the business will need to establish policies regarding temperature taking (including a use of a confidentiality statement), social distancing, offering flexible work hours and work options including work from home, flexible hours, staggering shifts, offering delivery services and curb side pickup. Until phase 5 is achieved water fountains, break rooms, and lunching together must be off limits. Testing, contact tracing, and sanitation/disinfecting, must become the norm. Policies should be in writing. Thank you attorney Wright for a wealth of information which will be of great value to all.. We will obtain her slide show and send it to all members.

- ☐ **SERVICE** Rotary members are needed to help with the Heart of Hope Food Pantry. We help every Thursday. The Pantry serves those using walkers and scooters starting at 4:30pm. The distribution to the general public will begin at 5:30pm and will last until 6:30pm. They do .not need our help to serve the early group, therefore, the volunteer time needed is only one hour. During the current health crisis, the needs of the less fortunate still exist and may even become greater. People still are hungry and still need the food they receive from Heart of Hope Food Pantry. The plan at this time is for the operation of the Food Pantry to continue and our help and support is still needed. But the distribution system of food has changed. Instead of a shopping format where the guest walks through the building selecting the food they want, the food now is pre-packaged into bags and just hand out to the guests. Contact with the public is reduced considerably. Food will be delivered to the elderly and disabled so that that population does not have to leave their homes. Used but sound plastic bags are needed now even more than in the past. Drop off bags anytime the Heart of Hope Center is open. #### **FOUNDATION MINUTE**

Welcome to May, Rotary's New Generation Month! This Rotary month is dedicated to the young and youth services, with special focus on the activities of Interact and Rotaract Clubs. While school related activities involving youth are mostly suspended due to COVID-19, there are several ways that Rotarians and youth involved in Interact and Rotaract are doing their best to make the world a better place. Virtual meetings are being held. Donations from Rotarians are being given to food pantries with the source of funds being the money that would have been spent on weekly meal tickets. During this time TRF continues to aid clubs in their individual projects. One of such club projects is the Rotary Club of Metro Bethesda, MD, which has donated \$53,000 to support three local nonprofit organizations focused on the frontline responders to the Covid-19 virus. The money will be distributed among the BCC Rescue Squads, Mobile Med and So What Else, a distributor of food, PPE, and other essential items. The \$53,000 was funded with contributions from the Metro Bethesda Rotary Foundation, the Rotary Foundation of Washington, Rotary District 7620, and The Rotary Foundation International World Fund. Rotary District 9211 comprises Rotary Clubs in the East African countries of Tanzania and Uganda. Rotarians in these two nations recently raised the equivalence of \$323,879 (USD) in their fight against infectious diseases. Handing over the check to the Prime Minister of Uganda, the District Governor (District 9211), Francis Xavier Sentame said that Rotarians are people of action and "Rotary is a service organization which puts it at the forefront in the fight against diseases like polio, malaria and now, Covid-19." The \$323,879 is a contribution of Rotary Clubs and other Rotary partners in Uganda and Tanzania, with matching funds from TRF.

### The Birdies for **Charity Bonus Fund** continues the bonus promise

The Birdies for Charity Bonus Fund was established to support the continuing efforts of the John Deere Classic, a 501(C)(3) not-for-profit organization, to provide bonus dollars to participating charities. To qualify, charities must be publicly supported and recognized by the Internal Revenue Service as a 501(C)(3) organization. All charitable contributions must come from a designated donor, and must not be part of a capital campaign. The Birdies for Charity program is intended to support charitable organizations, services, operations and programs. It is not intended to be used for endowment or brick and mortar charitable purposes.

As before, the tournament will provide a bonus to all participating charities. This year, all charities will be guaranteed a 5% bonus on amounts up to their prior year pledge total, or \$100,000, whichever is greater. Additional bonus dollars will be based on tournament revenues. The Birdies for Charity Bonus Fund is the source of these bonus dollars. This fund is supported with dollars from tournament revenues, individual donors, and corporations. These dollars will be distributed annually, and are designed not to compete with, but to enhance the benefits for the over 500 charities that participate in the program. 
