Liz Tallman is a veteran of public policy

and economic development work in the Quad-Cities. Before joining the chamber in 2009, she worked for the Quad-City Development Group as vice president of public policy and at the city of Davenport as an economic development program manager. In 2016 Ms. Tallman was named Chief Economic Development Officer of the Chamber and head of Quad Cities First the economic development arm of the organization. Quad Cities First has the following powers: 1. To function as an aid to civic, educational, economic and business growth and development in the geographical area of Scott County. 2. To foster and promote improvement and growth of the civic, educational, economic and business climate within the geographical area. 3. To enlist, encourage and promote cooperation among the county, municipal and other local governmental units. 4. To enlist, encourage and promote participation and effectiveness of all organizations which have an impact on civic, educational, economic, and business growth and development. 5. To collect and distribute statistical and other information with respect to matters affecting growth and development. And 6. To collect and expend funds as necessary or advisable in carrying out the purposes and attaining the objectives of the corporation. Ms. Tillman stated that Quad Cities First was formed when the Quad City Development Group, Iowa Quad-Cities Chamber and Illinois Quad-City Chambers merged. She noted that the Quad Cities has a Region population of 474,385 and a Labor force of:743,000 making the area truly a significant urban location for business and industry. She said manufacturing is a strong suit for the area. Tillman identified the regions "target industries" as: Advanced Metals & Materials – Led by industry-giant Arconic, the advanced metals & materials sector in the Quad Cities region is among the strongest in the nation. Agricultural Innovation - Deere & Company, Archer Daniels Midland, Nestle Purina, and Kraft Heinz are continuously innovating to feed the world, and their industry footprint is extraordinary. Corporate Operations & Support Services – The Corporate Operations and Support Services sector in the region grew by 5% in the past decade with almost 900 additional jobs. Companies are claiming their stake in the Quad Cities region. Defense – The Rock Island Arsenal is the backbone of the Quad Cities defense sector, serving as the home to U.S. Army logistics, manufacturing, training, and engineering. Logistics - An integrated, multi-modal logistics network - with the Mississippi River serving as a major contributor - is just the beginning of the Quad Cities' prowess in this industry. Ms. Tallman stated that Q.C. First serves our current industries and businesses and recruits new businesses and industries to the area. She said that over the past 9 years they have completed 79 projects resulting in 5,500 new jobs and \$1.3 billion in capital investment in the region. Prior to the pandemic issues of a shortage of skilled workers, Illinois high minimum wage, legalized marijuana, and federal tariffs faced were principal economic issues for the region. The Covid-19 pandemic changed emphasis and has hit the area hard. Q.C. First now is concentrating more of helping our existing industries. They have prepared a "tool kit" for servicing and rescuing existing businesses, helping businesses reopen safely, and giving long-term recovery insights. They post a daily blog listing Covid-19 resources for area business. Lots of good information in her program! Thank you Liz!

Instead of a shopping format where the guest walks through the building selecting the food they want, the food now is pre-packaged into bags and just hand out to the guests. Contact with the public is reduced considerably. Food will be delivered to the elderly and disabled so that that population does not have to leave their homes. Used but sound plastic bags are needed now even more than in the past. Drop off bags anytime the Heart of Hope Center is open. Call Steve Morenz to volunteer at 309-721-7632 or just show up any Thursday at 5:15 to help pack bags. Clients will not come into the food pantry until further notice.

Welcome to Week 2 of Rotary International's Youth Activity Month.



Notwithstanding, Interact and Rotaract clubs around the globe are joining with Rotarians to make the world a better and healthier place.

The Rotary Club of Accra Airport (RCAA), Ghana, along with its chartered Rotaract Club of Central University and two Interact Clubs have undertaken numerous projects and activities that span the six Rotary Avenues of Service. Additionally, the club recently marked its 20th anniversary virtually during which its president, Kofi Adu-Mensah, disclosed that RCAA has made a worthwhile contribution of \$182, 826 to The Rotary Foundation, stating that "Rotary adds richness to the lives of about 1.2 million members; richness that is not measured in monetary terms, but in the tangible benefit that we deliver to others and the personal joy and fulfilment derived from collaborating with good, honest and successful people for the purpose of serving our fellow man."

Food insecurity, worsened by the ravaging effects of Coronavirus, propelled members of the Rotary Club of Erin (Ontario) to donate \$10,000 to the East Wellington City Services Food Bank. Increased demand has placed pressure on the food bank and the donation will support the efforts of the Food Bank. The Birdies for Charity Bonus Fund was established to support the continuing efforts of the John Deere Classic, a 501(C)(3) not-for-profit organization, to provide bonus dollars to participating charities. To qualify, charities must be publicly supported and recognized by the Internal Revenue Service as a 501(C)(3) organization. All charitable contributions must come from a designated donor, and must not be part of a capital campaign. The Birdies for Charity program is intended to support charitable organizations, services, operations and programs. It is not intended to be used for endowment or brick and mortar charitable purposes.

As before, the tournament will provide a bonus to all participating charities. This year, all charities will be guaranteed a 5% bonus on amounts up to their prior year pledge total, or \$100,000, whichever is greater. Additional bonus dollars will be based on tournament revenues. The Birdies for Charity Bonus Fund is the source of these bonus dollars. This fund is supported with dollars from tournament revenues, individual donors, and corporations. These dollars will be distributed annually, and are designed not to compete with, but to enhance the benefits for the over 500 charities that participate in the program.
