Davenport Junior Theater

Daniel Sheridan has served as artistic director for Davenport Junior Theatre for the past 11 years. During that time DJF has shown tremendous growth in the nation's second-oldest children's theater. Since 2008, DJT (which serves area kids ages 3-18) has exploded from 300 registrations to about 1,800 this season, from 30 towns in the area. A big

growth engine has been the dance program, which launched in 2011 and has expanded from 60 to 240 student. At the end of June, Sheridan will resign as artistic director and the 36-year-old Davenporter and DJT alum will stay as the city's performing arts supervisor and will continue to oversee all DJT theater and dance classes, camps, and programs. Sheridan also will continue to oversee the city-owned facility at 2822 Eastern Ave., its development, and all rentals. Junior Theatre, Inc. creatively enriches the lives of Quad-City Area youth by offering education in the Performing Arts. Their Vision is to build on its lasting heritage to become a premier center for the performing arts for youth of all ages and ability levels, enriching their childhood experiences and their knowledge of the performing arts to lead them to a brave, bold tomorrow. DJT advocates six primary values: Self-Confidence: We enhance students' life-long ability to express themselves with clarity and conviction. Friendship: We provide a safe environment where students interact and form lasting relationships. Responsibility: We promote a team environment in which students rely on each other and themselves to fulfill their goals. Creativity: We foster individuality and unique ideas expressed on stage and beyond. Inclusiveness: We make programs and performances affordable and accessible to all. Fun: We believe that theatre arts should be enjoyable, and that FUN is essential to our quality of life. A rosy as the picture may look, it has not always been that way. Founded in 1951 by Leone Bredbeck and Mary Fluhrer Nighswander, their first production debuted in that same year. Junior Theatre rehearsed and performed in various parks, theatres, and churches. The dream of a permanent home came true in 1976 when the City of Davenport bought the Annie Wittenmyer Complex and designated three cottages and the chapel for the program. Over the next four years, Junior Theatre, Inc. invested approximately \$750,000 and countless volunteer hours toward its renovation. Over the following 10 years participation decreased as expenses increased. In 2008 the Junior Theater was on the verge of closing shop permanently when Sheridan, more or less pleaded with the city to give him one year to rebuild the program. Fortunately for the Quad Cities, his request was granted, and the success story took off to reach previously unheard-of heights. DJT now offers theater classes, camps, and workshops as well as dance classes in ballet, tap, jazz, and hip hop. There are even classes in tumbling. They continue to offer mainstage productions in the renovated Mary Fluhrer-Nighswander Theatre, a 350-seat house, fully equipped with a sound system and extensive lighting capabilities. The Covid-19 pandemic cause the program to close its doors on March 17th, however that obstacle only opened new opportunities. Rolled out just this week were datils on a new program of ZOOM Digital Classes. Starting in June each class will be a 4-week session on Zoom. In total, 50 Virtual classes are offered in theatre & dance with morning, afternoon and evening times available. Classes are open to kids ages 3-18. Registration is just \$20 per class. As Mr. Sheridan stated, although Davenport is in their name, Junior Theatre is a Quad Cities treasure serving children from more than 35 communities. Thanks Daniel for a great and informative program.



☐ **SERVICE** – Rotary members are needed to help with the Heart of Hope Food Pantry. We help every Thursday. The Pantry serves those in walkers and scooters starting at 4:30 pm. The distribution to the general public will begin at 5:30 pm as normal but will only last until 6:30 pm. The do not need our help to serve the early group, therefore, the volunteer time need is only one hour. During the current health crisis, the needs of the less fortunate still exists and may even become greater. People still are hungry and still need the food they receive from Heart of Hope Food Pantry. The plan at this time is for the operation of the Food Pantry to continue and our help and support is still needed. But the distribution system of food has changed. Instead of a shopping format where the guest walks through the building selecting the food they want, the food now is pre-packed into bags and just handed out to the guests. Contact with the public is reduced considerably. Food will be delivered to the elderly and disabled so that that population does not have to leave their homes. Used but sound plastic bags are needed now even more than in the past. Drop off bags anytime the Heart of Hope Center is open. Call Steve Morenz to volunteer to help at 309-721-7632 or just show up any Thursday at 5:15 to help pack bags. It's easy duty! Food will be packaged and handed out. Clients will not come into the food pantry until further notice.

FOUNDATION MINUTE

It's Week 3 of Rotary's Maternal and Child Health Month. As is now common knowledge, a lot has happened to derail the Rotary's calendar and agenda for this month. Most countries of the world have been sorely impacted by the devastating COVID-19. However, in spite of the alarming rates of death and destruction, Rotarians have been living up to the motto they hold so dear: Service Above Self. In line with this motto, Rotary clubs around the world have been doing their best to help communities cope with the on-going onslaught. Many clubs have taken to virtual meetings and donated the cost of their weekly meals to local food pantries and kitchens. District 5440, comprising 53 clubs have donated a total sum of \$53,000 to food banks and pantries, including \$11,500 to Wyoming Food Bank of the Rockies. This donation, matched by Rotary International Relief Fund, will provide 212,000 meals to people in the region affected by COVID-19. In a news release, the President of Rotary Club of Cheyenne, Robin Sims explained that the Wyoming Food Bank in 2019 distributed 8.2 million meals in partnership with food pantries, soup kitchens and shelters. "We are members of our communities and are proud that Wyoming Rotarians can support the people of Wyoming during this crisis."

The Rotary Foundation Club of Tulsa has donated a sum of \$68,000 to help 4 local nonprofit organizations cope with the demands of their clients. Meals on Wheels of Metro Tulsa received \$18,000 to replace its existing kitchen equipment with a new high-tech state of the art commercial kitchen. The Good Samaritan Health Services will receive \$16,000 for vehicle maintenance/repairs.

The Rotary Club of Berea (OH) acquired a Moonbeam 3 Module Disinfection Device for the Berea Fire Department. This device uses ultraviolet light to disinfect ambulances between 3 and 5 minutes. Moonbeam 3 replaces the previous manual disinfection which typically lasted a minimum of 20 minutes. District 7475 of New Jersey is at it again; this time donating a much-needed critical care equipment to Overlook Medical Center in Summit. To help the medical center cope with the demands of COVID-19, the district raised \$34,000 to buy one critical care bed for the ICU. This bed is useful for at least 12 years and can be wheeled from one area to another. The center needs at least 20 such beds. To donate, contact: https://www.njrotary.org

BOB SWANSON STEPS INTO THE SPOTLIGHT



This week's featured club member is Sergeant at Arms, Bob Swanson. He was born and raised in Monmouth, Illinois, the son of two teachers. His dad taught government and economics and also coached baseball and tennis. Bob's mother was a music teacher and church organist. His dad was a Rotarian and his mom was the Rotary Club piano player (before women could be members). Bob was active in music and sports throughout high school and college and continued playing adult basketball and softball for many years. Bob attended Western Illinois University where he earned a BA in Speech/Communications and an MA in Communication Arts. He participated on the university debate team for 3 years. Bob has had many careers, starting as a teenager delivering pizza and working on a

construction crew building homes and even a church. During his college years he was a radio disc jockey in Macomb, Illinois. After graduation he became debate coach and speech teacher at Maine East High School in the Chicago suburb of Park Ridge. The success of his debate team led to his hiring as associate debate coach and speech instructor at Augustana College and brought about his move to Rock Island. He got involved in the real estate business and ultimately began teaching part-time and working full time for David M. Weiner & Associates a Moline based Realtor. He rose through the ranks and after stints in sales, sale managing, and office managing, became vice-president and General Manager of the company. After 8 years with the firm Bob decided to return to school and enrolled in the Northern Illinois University College of Law. He earned his JD and returned to the Quad Cities in private practice with Schrager, Blackwood, & Nowinski in Moline. He became a partner in the firm and the name was changed to Blackwood, Huntoon, Nowinski, & Swanson. After 13 years practicing law, Bob retired and returned to his roots in education becoming Athletic Director for the Rock Island – Milan School District. He held that position for 14 years, retiring in 2012. Bob joined Rock Island Rotary in 1992 and served as club president for 2003-2004. He is a Paul Harris Fellow +5. He was our 2012 Excellence Award recipient, our 2014 A.T. Peara Award winner, and our 2019 Luckenbill–Wray Award recipient. In addition to serving as Club Sergeant at Arms, Bob is the editor of our weekly newsletter.

The Birdies for Charity Bonus Fund continues the bonus promise

The Birdies for Charity Bonus Fund was established to support the continuing efforts of the John Deere Classic, a 501 (C)(3) not-for-profit organization, to provide bonus dollars to participating charities. To qualify, charities must be publicly supported and recognized by the Internal Revenue Service as a 501 (C)(3) organization. All charitable contributions must come from a designated donor, and must not be part of a capital campaign. The Birdies for Charity program is intended to support charitable organizations, services, operations and programs. It is not intended to be used for endowment or brick and mortar charitable purposes.

As before, the tournament will provide a bonus to all participating charities. This year, all charities will be guaranteed a 5% bonus on amounts up to their prior year pledge total, or \$100,000, whichever is greater. Additional bonus dollars will be based on tournament revenues. The Birdies for Charity Bonus Fund is the source of these bonus dollars. This fund is supported with dollars from tournament revenues, individual donors, and corporations. These dollars will be distributed annually, and are designed not to compete with, but to enhance the benefits for the over 500 charities that participate in the program.
