District which encompasses the metropolitan Illinois Quad Cities and the western half of rural Rock Island County. He currently serves as Chairman of the Personnel & Pensions Committee. Halpin received his bachelors' degree from Roger Williams University and his Juris Doctorated law degree from the University of Illinois. He served as a legislative aide to former Congressman Lane Evans, and as a former public guardian for Rock Island County. He has served on the board of directors of Bridging the Gap: and Stand Down for Homeless Veterans. Representative Halpin resides in Rock Island with his wife and two children. Mr. Halpin divided his comments into three major areas: the COVID pandemic; the State Budget; and the recently enacted Criminal Justice Reform act. Starting with the pandemic, Rep Halpin said Illinois is doing better than many states in the distribution and administration of vaccine. He acknowledged that Rock Island County has suffered from a shortage of vaccine and stated he is working with the Department of Public Health to obtain more supplies. Halpin also said that he believes we are headed in the right direction and that there is now a light at the end of the tunnel. His prediction was that within the next several months Illinois should be good shape and able to ease more of the COVID restrictions. Turning to the Governor's recently proposed Budget, the Representative said the pandemic created a revenue loss for the State with business being closed resulting in the loss of tax revenue. He noted however that the loss was not as severe as had been predicted and that the State was able to pay off some debt that would have had to be paid out of the new budget. Stressing that the Governor's budget is a "proposal", he said the General Assembly and Senate would review and debate the budget and may make changes prior to returning it to the Governor for signature. One thing Halpin is hoping for is to get an increase in Education funding put back into the budget. The Governor's budget kept most spending flat, including Education, which was not fully funded this past year. He said the proposed budget asks for no new taxes, other than closing some corporate tax "loopholes". Opponents argue those changes will be extremely harmful to local businesses. Halpin also said that the budget assumes no additional federal funds, which could possibly come if an additional COVID package is passed by the US House and Senate. The Representative then turned to the Criminal Justice Reform bill, which he noted was highly controversial. It was strongly opposed by law enforcement agencies and Halpin admitted it was not a "perfect" bill. But weighing the benefits against the areas he did not support, he felt overall it was worthy of support and he voted for the bill. He did push for and got one significant change in the bill prior to lending his support, that was to keep in place the qualified immunity provision of the current law for law enforcement personnel. He noted the bill eliminates cash bail and makes the decision as to release or incarceration pending trial based on severity of the crime, potential for endangerment of the public, and potential for fleeing, rather than ability to pay. The bill bans choke holds and neck and head restraints, limits the use of impact projectiles (rubber bullets, etc.), requires body cameras for all law enforcement personnel by 2025, limits who can alter or edit body camera footage, and requires more officer training in mental health, de-escalation, and the use of force. The bill also makes officers more accountable to misconduct and 'decertifies" bad actors so they can't just move to another jurisdiction and continue. In response to questions, Mr. Halpin said that legalizing marijuana has brought in significant tax revenue and has not resulted in more DUI arrests or traffic accidents. He said the recent leadership change with Mike Madigan's resignation has resulted in a more technologically aware leader and a more inclusive democrat caucus. He stated that a bill to provided pre-judgment interest is pending and would be beneficial to persons who successfully prove their claims. Thanks to Representative Mike Halpin!

## **FOUNDATION MINUTE**

Welcome to Week 4 of RI's Month of Peace and Conflict Prevention/Resolution.

Promoting peace is one of The Rotary Foundation's 7 areas of focus. As the month of Peace and Conflict Resolution draws to a close, The Foundation Minute will focus this week's attention on the Rotary Foundation's funded Peace Centers.

According to Rotary International's website, the Rotary Peace Centers were created in 2002 to identify and train highly qualified professionals to become agents of peace. The purpose of these "agents of peace" is to: promote national and international cooperation, peace, and the successful resolution of conflict through their service activities.

Each year, Rotary awards up to 130 fully funded fellowships for dedicated leaders from around the world to study at one of our peace centers. Through academic training, practice, and global networking opportunities, the Rotary Peace Centers programs train "the agents of peace" to become professionals or practitioners in being effective catalysts for peace. The fellowships cover tuition and fees, room and board, round-trip transportation, and all internship and field-study expenses.

Since the program began in 2002, the Rotary Peace Centers have trained more than 1,400 peace fellows who now work in more than 115 countries. Many serve as leaders in governments, non-government organizations, the military, education, law enforcement, and international organizations like the United Nations and the World Bank. Each year the Rotary Foundation awards up to 50 fellowships for master's degrees and 80 for certificate studies at premier universities in 7 countries: England, Thailand, United States, Japan, Australia, Sweden and the most recent, Uganda in East Africa.

We believe that one must live one's life with compassion. Our wish is that, as citizens of the world, we can create a society where people of all regions in the world esteem and care for others. By supporting the Rotary Peace Centers, we foster compassion and enhance the impact of the many good things that the Rotary Foundation does. ## IN PERSON MEETINGS

To keep all aware of the Board of Directors' consideration of returning to "live" meetings, here is what is going on. We periodically review the COVID guidelines provided by the Illinois Department of Public Health and also check with the Quad City Botanical Center to see what they are offering and recommending. Currently Health Department regulations limit gatherings to no more than 50 people and require masking and social distancing. Masks may be removed for eating (to be replaced immediately upon completion of eating) and when speaking at the rostrum. Currently the Quad City Botanical Center is "closed" for group meetings and will not reopen until April 1st. Our caterer, Bridges, will provide lunch when the Botanical Center reopens. How the lunch is provided will depend on the number of members we believe will attend. If numbers are sufficient, Bridges will provide a "served buffet". Members would identify what items they want, and Bridges staff will handle the serving utensils and fill a plate for the member. If the number projected to attend is smaller, pre-boxed lunches will be provided. We are currently inquiring as to the exact number required for a served buffet. The Botanical Center will set tables at a minimum of six feet apart and will limit the number seated at each table to ensure compliance with social distancing guidelines. As much as we desire to resume in person meetings, the health and safety of our members it our top priority. When we do return to the Botanical Center, we anticipate temporarily offering a ZOOM option for those who are not comfortable returning to in person meetings. The Board discusses this issue at each board meeting and will keep you informed.
