Previously Ms. Tallman served as Chief Economic Development Officer for the Quad Cities Chamber of Commerce/Quad Cities First; Vice President Economic Development for Quad Cities First/Quad Cities Chamber; Vice President Public Policy for the Quad City Development Group; Economic Development Manager for the City of Davenport;

Community and Economic Development Program Director for the Bi-State Regional Commission; and in Job Training Administration, for Black Hawk County, Waterloo, Iowa. She holds bachelor's and masters debrees in Public Administration from the University of Northern Iowa. Ms. Tallman explained that DARI's new partnership with the City of Rock Island has eight areas of emphasis. !. Business Resources. DARI will act as a collection center for all types of information necessary for successful business operation. Currently over 1,000 bisiness in Rock Island have signed up and almost 800 have already used Business Resources data. 2. Business Development. DARI currently has 38 projects underway. Seventeen involve expansion of current businesses and 21 involve attracting new businesses to the city. To help in development \$9.7 million in new investment has been committed to downtown Rock Island. During 2020 over \$70 million for business expansion was planned or underway. 3. Business Corridors. Several Rock Isalnd Business Corridors have been established such as the Hilltop Business Association, 11th Street Corridor, and Downtown Development. Although Covid has limited the ability to actively be out in the corridors, DARI is committeed to aiding these organizations with both finance and information. 4. Product Development. Rock Island is the product and DARI is working to promite and enhance that product by removing blight, providing grants and expertise to improve the quality of buildings, office, manufacturing, and warehousing space. Rock Island needs to show prospective businesses that our city has excellent facilities available to meet their needs. This also includes quality, affordable housing for business management and employees. Tallman used the "Live-Work-RI" program as an example. That program have provided Rock Island homebuyers with downpayment and closing cost assistance with an average of over \$5,600 per home purchaser generating over \$3 million in real estate transactions. 5. Financial Assistance. DARIS has provided a "Bussiness Guide of Programs' for Rock Island businesses to help them identify programs that are available to assist and meet their needs. They also provide direct grants to businesses inclucing \$140,600 in grants for Round 1 covid relief to Rock Island small businesses and an anticipated \$280,00 in Round 2 grants. 6. Marketing & Communication.. Here DARI is working to increase awareness and to promote Rock Island. They are doing this through an enhanced and improved website and programs such as "Love Local" which provided free advertising for Rock Island businesses. 7. Partnerships. DARI partners with numerous entities with the common goal of Rock Island Development. The City of Rock Island is one such partner who is helping to fund DARI's programming and staff. Partnerships also exist with real estate brokers, banks, etc. 8. THIS TOWN **ROCKS** is an program to publicize the many benefits of living and working in Rock Island. Among their newer efforts has been to directly take on the "perception" that it is cheaper to do business in lowa. DARI has developmed data to show that in identical scenarios, taxes and the overall cost of doing business are less in Illinois than in Iowa. Overall it was a data packed, informative and intersting program. Thank you Liz Tallman!

FOUNDATION MINUTE

Welcome to Week 3 of Rotary International's Month of Water & Sanitation.

On March 11, 2021, members of the Rotary Club of Boothbay Harbor, Maine, welcomed TRF chairperson, Brenda Cressy to their club for a grand occasion. Cressy was at the club to announce a humongous gift to TRF by the Otto & Fran Walter Foundation, a charitable organization based in New York City. The Otto & Fran Walter Foundation's gift of \$15.5 million was described by Cressy as "... the second largest gift in Rotary International's history...second only to the one from the Bill and Melinda Gates Foundation." The gift was facilitated by board members of the Walter Foundation, who also happened to be members of the Boothbay Harbor Rotary Club.

Boothbay Harbor Board President Martha (Marty)Peak Helman, Past President Frank Helman and members Chip Griffin and Ken Bradsell recalled that the idea of doing something similar to the Rotary's Peace centers cropped up during one board meeting of the Otto & Fran Walter Foundation. The board was discussing a successful Rotary International scholar program focused on promoting world peace with centers around the globe. "What about one in the Middle East? Wouldn't that be the ultimate tribute to Otto, and be an incredible way to change the world," Marty Helman, the 2020-21 chair of TRF's Peace-Major Gifts Initiative had asked. Expressing immense gratitude of TRF, Brenda Cressy said that TRF has always wanted a Middle East Peace Center since 2018. The new center will be Middle East/North Africa (MENA) region. Once the Middle East peace center is established, the Walter Foundation's endowment will fund 20 scholars per year in perpetuity, and the gift will be the last, according to Marty Helman.

In another report, Rotary District 7120, western New York, received a Disaster Relief Grant of \$24,585 from TRF. The money will be used to purchase relief materials for those who are at a high risk for contacting COVID-19. Eleven counties will benefit from the gloves, masks, disinfectants, wipes, gowns and hand sanitizers.

When the coronavirus hit about a year ago, TRF quickly mobilized and awarded 319 COVID-19 specific disaster response grants for \$7.9 million. To date, we have further awarded 317 COVID-19 global grants for \$24.1 million which, combined with previously approved global grants...has made for a total outflow of more than \$32.7 million." Not all Crooks are Stupid – MORE Tips for Staying Safe!

LONG-TERM PARKING

GPS:

Someone had their car broken into while they were at a hockey game. Their car was parked on a lot which was adjacent to the arena and specially allotted to hockey fans. 
address (like a store or gas station) so you can still find your way

ROTARY MOTTO'S

Did you know that Rotary has two mottos?

The first motto of Rotary International, "He Profits Most Who Serves Best," was approved at the second Rotary Convention, held in Portland, Oregon, in August 1911.

The phrase was first stated by a Chicago Rotarian, Art Sheldon, who made a speech in 1910 which included the remark, "He profits most who serves his fellows best."

At about the same time, Ben Collins, president of the Rotary Club of Minneapolis, Minnesota, commented that the proper way to organize a Rotary club was through the principle his club had adopted-"Service, Not Self."

These two slogans, slightly modified, were formally approved to be the official mottoes of Rotary at the 1950 Convention in Detroit-"He Profits Most Who Serves Best" and "Service Above Self."

The 1989 Council on Legislation established "Service Above Self" as the principal motto of Rotary since it best explains the philosophy of unselfish volunteer service. The 1989 Council's vote to admit women into Rotary clubs worldwide remains a watershed moment in the history of Rotary and led to altering the original logo to: "One Profits Most Who Serves Best".
