President, and Chief Executive Officer of Illinois Casualty Company. Arron holds a bachelor's degree in Accounting from Michigan State University and a Master of Business Administration from Saginaw Valley State University - College of Business and Management. Prior to rising to his current position Arron served as Assistant Controller, Vice President, and Chief Financial officer of ICC. Arron joined Rock Island Rotary in 2019. He was joined at the rostrum by Jack Cullen, Director of Downtown Rock Island a joint City of Rock Island – Quad City Chamber effort to redevelop and revitalize downtown Rock Island. Mr. Cullen previously served as Manager of Marketing & Communications for the Quad Cities, Iowa Metropolitan Area and was project manager of Q2030. He holds a Bachelor of Arts from Augustana College and a Master of Business Administration from the University of Iowa. Arron is chairman of the Downtown Rock Island Steering Committee, which has helped guide plans for the downtown improvements. The plan is a major, multi-million-dollar renovation and redesign of our downtown district. Arron began the presentation first telling of his hometown, Flint, Michigan. As a youngster Arron said that Flint was a thriving community and was known as the city that manufactured more automobiles than anywhere else in the world. Then as time passed he saw the community deteriorate and become known for their tainted water supply and as the third city with the third highest crime rate in the nation. He said he has seen firsthand what can happen to a community if renovation and redevelopment are not priorities. He also noted Illinois Casualty Company's stake in Rock Island. The company was founded in Rock Island. Even though it now serves 13 states, they have kept their home office in Rock Island and in 2003, at the insistence of the company president at the time, built a new national headquarters in downtown Rock Island. Therefore, ICC as well as a philanthropic and community interest, has a financial interest in seeing the downtown thrive. Sutherland said, "ICC cares about the community they are in." He then turned the program over to Jack Cullen. Mr. Cullen stated that planning for the revitalization of the downtown and establishment of the steering committee began over a year ago. The plan has five major areas: Renovation of the Great River Plaza; Development of Arts Alley; Establishing a pedestrian gateway to Schwiebert Park and the riverfront; Development of a downtown dog park; and Street scaping including new light posts and lighting, benches, restaurant outdoor eating areas, repainting and building façade improvements, and general landscaping. The City Council directed \$2.5 million in American Rescue Plan Act funds toward the project with another \$1.5 million in Tax Increment Financing District revenue. They also have a pending \$3 million matching grant from the State of Illinois Rebuild Downtowns Capital Grant Program, which would bring the total to a \$7 million for the project. Approval of the grant application is anticipated next week. Mr. Cullen said the first project to be tackled would be reconstruction of the Great River Plaza, which is the 2nd Avenue pedestrian mall. The plan is to make the Plaza more pedestrian friendly. Outdoor dining spaces will be installed along with enhanced lighting, small park areas with trees, seating, and repainted pedestrian crosswalks. The plaza will be the core focus area, but the improvements will expand out from there. Cullen than returned the rostrum to Arron Sutherland who said the hope is to establish an SSA (Special Service Area Tax) of 1.15% on property in the downtown area which must be approved by the city council. Funds would be used exclusively to maintain and provide extra services in the area. The tax would expire in 5 years and would require a review and renewal by the City Council if the project proves successful.

FOUNDATION MINUTE


MAY is the Youth Service Month of Rotary International.





Heart of Hope will have their grill going and serve up hot dogs, chips, and beverages for lunch following the cleaning.

This would be a great service opportunity for any Rotarians willing to spend a few hours on a Saturday morning in exchange for lunch with some great people. The date is Saturday May 21st from 9:00 am until noon, with hotdogs on the grille afterwards.





Rock Island Rotary has partnered with Heart of Hope for many years starting with helping distribute food at their food pantry on Thursdays. That involved about 90 minutes of service. When the pandemic hit our attendance at the pantry ceased and our service switched to collecting plastic bags and donating warm winter coats to their clothing pantry. Their Giving Hope House is a new venture for Heart of Hope. The property was acquired and then the job of fundraising and total renovation began. To date they have removed the old boiler heating system, radiators, kitchen cabinets, tile flooring, bathroom fixtures, and installed a completely new HVAC system, a completely new bathroom and kitchen. They plan to plan to replace the front and back porches, create a nice deck area; and give a fresh coat of paint to both the inside and exterior. A renovated electrical system and landscaping will complete the renovation creating a beautiful home for the neighborhood and adding value to the community. The home will serve as a place for training and re-entry services. This is a great chance for service with no request for a check or pledge!

Sherwin-Cole is a Rock Island native, whose stepmother is Liz Sherwin (head of the Illinois-Iowa Center for Independent Living). Tyla dropped out of high school in 10th grade and later got her GED. She then attended Black Hawk College and got an Associate Degree at Scott Community College. She earned her bachelor's in sociology from Ashford University in Clinton, and subsequently a master's in museum studies at Western Illinois University in Moline. "I am a living example of where you can go and who you can be," Sherwin-Cole said. We are delighted to have her join Rock Island Rotary. Her sponsor is Angela Campbell. Tracy Pugh's says his career as a correctional officer for the state of Illinois taught

him the critical relationship between education and a potential life of crime. That led him to seek election to the Rock Island-Milan School Board, a position he won as the top vote getter in our last general election. It also kindled his interest in Rotary and our commitment to literacy, children, and education. In addition to his work in education, Tracy serves as a counselor for Family Resources and is on the Board of Directors of the Quad City Botanical Center. He also is the Criminal Justice Committee chairman for the Rock Island County NAACP. His enthusiasm for Rotary has already shown as he has volunteered to be a Sergeant at Arms Aide and stayed after our last two meeting to learn what that job entails. BOARD OF DIRECTORS STRENGTHENS COMMITMENT TO WATER PROJECT

It has been five years since Rotarian Sam Wray and wife Hilde made a \$10,000 donation to kick-start what has become our Western Illinois-Eastern Iowa Water Project. Over the past five years fourteen other Rotary Clubs in Illinois and Iowa have joined our project along with three Interact, one EarlyAct Club, and our Rock Island Rotary Club Foundation. Plus 43 individual Rotarians, including seventeen members of our club have donated to the project. Nearly \$90,000 has been raised resulting in the purchase and delivery of 245 water filters now serving over 17,000 impoverished children in rural Kenya. Previously our Club by vote of the Board of Directors purchased three filters. At yesterday's Board of Director's meeting by unanimous vote it was decided that the Club would purchase two filters each Rotary year using funds that previously were given in honor of our program guests speakers for the benefit of Earl Hanson Elementary School. Noting that we have established the annual Trivia Night as a source of regular funding for Earl Hanson, the Board determined that the speaker honorariums could be directed to the pressing need for safe water in thirdworld countries. So don't be surprised when you hear our president advise our guests that in their honor, a contribution will be made toward the purchase of a state-of-theart filtration system that will provide children who currently have no access to safe, sanitary water in rural villages near Nairobi, Kenya with safe, pure drinking water and sanitation education. The Board is hopeful that their commitment to the project will encourage other clubs and our own members to also re-commit to this incredibly important project.
