Dr. Julie Schroeder, M.D. is Board Certified in Family Medicine. She was born in Minnesota but grew up in the suburbs of Salt Lake City, Utah. family's dairy farm - that is still active today - and has worked for CNH Industrial since college. Dr. Julie attended Loyola University Stritch School of Medicine in Chicago. After this, Jay and Dr. Julie moved to the Quad Cities, and she completed her residency in Family Medicine at the Genesis Family Medicine Residency program. She has practiced in this area for over 20 years with experience in outpatient family medicine clinics on both sides of the river. Jay and Dr. Julie are the proud parents of 3 children who have all attended Morning Star Academy in Bettendorf. Their daughter is attending Iowa State University and their twin sons are both seniors in high school. They are blessed to live close to both sets of grandparents and do a lot with their extended families. The family is actively involved with their church, Our Savior Lutheran, in Bettendorf. The Schroeders are avid travelers and love the chance to visit, explore, and serve in new countries. Dr. Julie has served on mission trips to the Dominican Republic, Costa Rica, and Peru. Dr. Julie feels that God truly put her in this place at this time to develop and grow Life & Family Medical. "It is a blessing to use the healing talents I have been given and develop new business skills in a setting where it is all about doing what is best for the patient while honoring my Christian values. I think I have been preparing my whole career for this opportunity." Life and Family Medical is a Direct Primary Care clinic. Direct Primary Care (DPC) is an innovative approach to healthcare. Life & Family Medical does not accept insurance so there are no middlemen and no administrators, it's only you and your doctor making decisions about your healthcare. Instead of the doctor working for the insurance company, the doctor works for you. Members pay a monthly membership fee which covers all office visits and provides access to their doctor via phone, email, text, and telemedicine, even after hours if needed.

Fees are \$30 for children to 18 years, \$50 for 18 to 26, \$80 for 27 to 45, \$95 for 46 to 60, and \$110 for over 60. If there are more than two children, after the first two the fee drops to \$20 for additional children. For the monthly fee you can call, email, or go see the doctor whenever needed. There are no co-pays. If lab work or prescriptions are required you can use insurance if you have it or dl lab work through Dr. Julie for her cost at the lab of \$4 to \$6 is depending on the purpose of the work. You can also order prescriptions through Dr. Julie and get them at her wholesale costs. Life & Family Medical is a non-profit entity so there is no addition charge added to the cost of lab or pharmacy costs. Direct Primary care is a relatively new system of providing care in the United State. Nationwide there are about 1,500 Direct Primary Care organizations. Dr. Julie is the first DPC in the Quad Cities, although two others are anticipated to open in the near future. Dr. Schroeder noted several advantaged to this form of health care. 1) There is a set and budget able costs for primary health care. 2) You have direct access to your doctor. You don't deal with insurance, or nurses, or aides, or receptionists. 3) You are 1e of 400-600 patients seen by the doctor rather than 1 of 2,500 seen in a typical medical practice. 4) Care is immediate and personalized. When you call or email, the Doctor answers and speaks with you. 5) Decisions regarding your care are made by you and your doctor with no interference or restrictions from insurance companies. Life & Family Medical also provides "scholarships" to provide care for those unable to pay the monthly fee. This is done using donations received from many sources including a Birdies for Charity campaign. Thank you Dr. Julie for an informative in very interesting look at new alternatives in meeting the high cost and sometimes lengthy delays in today's medical care system.

- Almost 11,000 Clubs


Effective July 1, 2022, Rotaract clubs can be either partners or hosts of a Global Grant if they have previously partnered with a Rotary Club on a Global Grant.


#### STILL TIME TO JOIN JOHN PHILLIPS' 2022 BASEBALL CHALLENGE!


