University and her MS in Education Administration from Western Illinois University and is currently working towards her doctorate degree in educational administration. She began her career as an English teacher at Rock Island High School. She then moved into administration as a Dean at Rocky, then as an Assistant Principal at the Rock Island Academy, and then to her current position as principal of the Thurgood Marshall Learning Center. In each phase of her career, Ms. Edwards displayed Excellence in leadership, motivation, and empathy. The Marshall Learning Center is perhaps the most challenging administrative assignment in the district. When students seeming cannot achieve in the traditional school setting as a result of discipline, emotional, or social issues, they are "sent" to the Marshall Center housed in what was formerly Grant Elementary School. Tia's team of educators have the special abilities and training to deal with the issues and behaviors their students exhibit. As leader of the team, Tia has the personality, knowledge, and empathy to connect with her students. It is said, "Student's don't care how much you know until they know how much you care". Tia is well known in the District as a teacher/administrator that truly cares about her students. She began her comments stating that the Marshall Center receives students from 7th through 12th grade. She noted that many of the Marshall students are dealing with trauma in one form or another. She gave examples without names including a student who scored "As" and "Bs" in class but hid in the restroom during lunch period, others have behavior issues, some lack any reasonably reachable guardian or adult mentor. Others have emotional issues or socialization issues. Some would prefer to be marked absent that to attend and answer a roll call. When students are referred to the Marshall Center, each goes through an enrollment interview. All building teachers, the student, and their parents/guardian, the principal, and counselors are present. They don't dwell on why the student was referred, but concentrate on asking the student what they hope to accomplish, what goals they have, and what issues they believe they need to overcome. They then work to develop a program that directly meets the needs of that student. Ms. Edwards said they also have a daily check in procedure that ensure that the student is greeted, is spoken with, and lets Ms. Edwards know if the student is happy, depressed, not feeling well, or agitated. She believes this is very important and gets the student's day started off well. She said if students miss their bus or have transportation they know to call and they will be provided with a way to school. Ms. Edwards then introduced one of the Marshall Center Teachers, Chris Britton (also a former member of our Club). He spoke of how he teaches his "Hip Hop, Creative Writing & Art" class. He plays Hip Hop music in the background during class. He believes it encourages the students to listen rather than take, or disrupt. He asks the kids what they believe others think of them which lets them start to open up emotionally get things off their mind. He then sets lofty and rigorous goals for the class and lets the students know that together they will achieve those goals. He encourages the students to write what they are thinking and to share their thoughts with the class. He teaches students to be respectful of other's feelings and trust is gained as the kids begin to express themselves. Last year he told them their writings would be published in a book. He was able to get the book printed and they had a book premiere party for the class. He said many of the students make up past lost credits, graduate, and become productive citizens. Thanks to Chris and Tia for a very interesting program.

RI's Month of Peace & Conflict Resolution

As of midnight on Saturday, February 11, 2023, the projected casualties of the devastating earthquake that hit Turkey and Syria had risen to over 30,000 men, women, and children dead. Additionally, millions have been rendered homeless in the bitterly frigid winter weather. The Rotary world responded to this catastrophe immediately. According to RI's website, President Jennifer Jones activated our disaster response efforts, communicated with the affected districts, and encouraged governors in those regions to apply for disaster response grants and share information about their relief efforts so that Rotary can amplify the calls for support. Many Rotary members are asking how they can help. Here is how to have the greatest impact:

- 1. You can give directly to our Rotary partner ShelterBox, which is mounting a massive emergency shelter response program in the area: https://shelterbox.org/turkey-earthquake/
- 2. You can give to the Rotary International Disaster Response Fund, which will soon be targeting Turkey and Syria as designated areas for help: https://my.rotary.org/en/disaster-response-fund








MOLLY IS CALLING FOR HELP!

Nice To Have a Rotary District Coordinator in Our Club!

The many distinct categories of giving offered by Rotary International can be confusing. That's when having a District official in our club really comes in handy! Mark Mayeski is the Rotary District Paul Harris Society Coordinator. Today he provided a great clarification on what is often confusing. He noted that a Paul Harris Fellow award is given when a Rotarian has donated \$1,000 to the Rotary International Foundation. He also explained that our club is one of a very few that offer members help achieving that award. Once a member has given \$600 our club contributes the last \$400 as our commitment in support the Paul Harris Fellow program. As a member contributes more for each additional \$1000 they receive jeweled pins recognizing Paul Harris +1, +2 and on up. He contrasted that with joining the Paul Harris Society. To join a Rotarian makes a written commitment to donate \$1,000 or more each year to the Rotary Foundation. There is no "consequence" if circumstances cause an interruption in the giving. Mark has the necessary documents for anyone wishing to become a Society Member. Her also noted that the Rotary International Foundation provides services internationally and returns a potion of the money given to Rotary District to use for District grants. We also have a Rock Island Club Foundation. Contributions to that entity are used exclusively for projects to better the lives of the citizens of Rock Island
