"Planting Books: Seeds 4 a Better Future"

Tamara Felden, formerly the owner of the The Artsy Bookworm bookstore, planted a seed last year when she launched "Planting Books — Seeds 4 a Better Future", a new nonprofit organization. Her goal was to provide 2nd-grade students at the Rock Island Academy a high-quality books to call their own.



Children fell far behind in reading skills during the pandemic and Felden is a firm believer in getting at root causes of problems. She thought, "What can someone with relatively modest means do to give children long-term advantages?" Felden

credits her own early childhood reading opportunities with the path that led to a PhD and a career working and teaching in various positions at prestigeous colleges and Universities. Now retired she wanted to do something that would have a long term and positive impact on our community. Consulting with Thomas Ryan, principal at the Rock Island Academy, one of the District schools with a majority of students from low income households and broad racial diversity, and teachers Deborah Noble, Becky Lapp, and library paraprofessional Melissa Knoeferl, Felden learned that many children do not have good reading material at home. Changing that could make an important difference in a child's reading ability. Dr. Felden stated that countless studies tell how important strong reading skills are for the intellectual and social development of a child. This is particularly important in the aftermath of the pandemic. The organization gives high-quality children's books to encourage students to read at home in their unscheduled time. The next step was to settle on a population of students and select high-quality reading materials, she said. They agreed that 2nd grade would be the group to aim for, because at that age children no longer depend on an adult to read with them. "We didn't want to inadvertently create an additional burden for parents who often already have so much on their plate," Felden said. They learned that every 2nd grade student in the school could be given three top quality age appropriate books for thirty to thirty-five dollars. A board of directors was established and a 501(c)3 not-for-profit organization was formed. Donations were gathered adequate to fund the first purchase of books in 2023. It was decided that every child and each of the second grade teachers would receive the same three books. Providing the same set of three books to every child encourages discussion among students and allows teachers to draw on the material in class. They also wanted books with positive messages and beautiful illustrations that would entice and assist those struggling with reading skills. They also looked for books with messages that were similar to life experiences the children could relate with. Dr. Felden explained that she named the orgainzation "Planting Books - Seeds 4 a Better Future" because of her love of reading and gardening and the similarity between gardening and literacy. She, said, "They both start small as seedlings needing care and nurture. But they both grow into wonderful, huge, and lasting treasures." The books were presented at the beginning of the current school year at a gathering of all the 2nd grade students in the Rock Island Academy's cafeteria. Feldon said the kids were excited and loved having books of their own to take home and a letter was sent to the parents explaining their child had received the books as a gift from Planting Books: Seeds 4 a Better Future. The organization is now fundraising to finance the book purchase for next school year. There are 96 in the incoming 2024-25 second grade class plus four teachers. So the minimum needed is \$3,400. Dr. Feldon invited us to take a look at their webpage, www.planting-books.org for more information and ways to support the effort. We applaud the work Dr. Felden is doing and thank her for a very informative presentation.

ROTARY FOUNDATION MINUTE

The Rotary Club of East Nassau (The Bahamas) jubilantly crossed the finish line at its Million Dollar Dinner on Saturday night, achieving an ambitious goal of raising \$1 million to help fund Rotary Foundation projects that improve the lives of countless individuals. The Million Dollar Meal concept was started in 1959 by a club in Stoughton District (Wisconsin). It is now an established part of Rotary International fundraising for The Rotary Foundation. Speaking at an interview with The Nassau Guardian, president of Rotary Club of East Nassau, Christian Knowles describes the feat as "surreal,...to do something that no other club has done before is so empowering and inspiring and at the same time, I know it's gratifying because I know that those other clubs are going to do the same thing and I want them to do the same thing and I can't wait for them to do it." The fundraiser was attended by donors who made pledges of \$10,000 or more to The Rotary Foundation and by Rotarians, among them Barry Rassin, past Rotary International president, and chairman of The Rotary Foundation Board of Trustees.

Past Rotary International President Jennifer Jones who was the keynote speaker, recently traveled to Abaco and Grand Bahama to see firsthand the difference Rotary made on the ground in the days, weeks and months after the ferocious Hurricane Dorian uprooted the lives of tens of thousands of people. Speaking with The Nassau Guardian, Jennifer said, "What has been really wonderful is to be able to see some of the work that's been done hands on by the clubs, and in particular East Nassau, and then to culminate it tonight with this huge \$1 million fundraising dinner and to cross the finish line in real time while we were here was nothing short of remarkable, and what this means is that it allows us as an organization to do so much good for people in the community here and in other communities around the world."
