



# Dr. Heidi Lung Dir. of Museum Studies WIU Quad Cities

Heidi Lung, Ph.D. is Associate Professor and Director of Museum Studies. She earned her bachelor of arts degree in art history at Lindenwood University and her master of arts in history and museums studies and her Ph.D

in Education from the University of Missouri – St. Louis. She was Program Director and Associate Professor for the University of Iowa Museum Studies program for seven years and served four years as President of the Board of Directors of the Iowa Museum Association. She has over 25 years of experience in museum education, community outreach, and leadership for museums and organizations, including the Saint Louis Art Museum, Challenger Center for Space Science Education, the Missouri Historical Society in St. Louis, and the Iowa Museum Association. In June of 2022 she accepted the position of Associate Professor and Director, Museum Studies Graduate Program at Western Illinois University-Quad Cities. Dr. Lung began by saying that the first job she had came from answering a newspaper job ad seeking applicants for the St. Louis Art Museum. She said she went in not knowing exactly what the job would entail, but found it to be a fantastic experience. She was asked to create an audio tour of the museum the visitors could listen to as they walked through the various exhibits. She wrote grants and curriculum for students and teachers who visited the museum. It was

a job she loved and thought she would stay forever until another opportunity came knocking. We all know of the NASA Shuttle "Challenger", the tragically broke apart 73 seconds into its flight, killing all seven crew members aboard. Subsequently in 1986, the families of the crew established the Challenger Center as a way to honor their loved ones while keeping their educational mission alive. A Challenger Learning Center Opened in St. Louis and needed persons with professional museum training. Dr. Lung moved to the Learning Center where she got to design exhibits, lead students on simulated space missions to the moon, Mars and other celestial destinations. She leaned to create exhibit label descriptions. She dressed daily in a NASA flight suit and lead student groups by assigning jobs with specific tasks to be completed during the simulation. The Center had both a control center simulation and a shuttle simulation. Dr. Lung was particularly interested in learning how people learn. She noted that people who visit museums come to learn, but want to pick and choose what they want to learn. Her next job move was to the University of Iowa who has had a Museum Studies program for more than 100 years. She earned her Doctorate in Education and began teaching others the many aspects of museum establishment, management, maintenance, programming, and promotion. After seven years at lowa she accepted the position at Western Illinois University – Quad Cities with an opportunity to teach graduate level students. She explained that Museum Studies students come from many diverse fields of study. All have a love of learning and museums. She urges her students to follow their hearts and take risks – just like she did! She closed by saying it is a wide open and expanding field with over 35,000 museums in the United States and a major shortage of trained museum professionals. Thank you Dr. Lung for a educational and very interesting presentation!

#### ROTARY FOUNDATION MINUTE

The news this week, in an online report by Arnold R. Grahl, highlights the continued effort of TRF to lighten the burden of victims of devastating disasters.

A year after the most powerful earthquake in nearly a century devastated parts of Turkey and Syria, Rotary members have helped people rebuild with container homes for hundreds of families, hospital equipment, and other essential support.

A special Disaster Relief Fund created by The Rotary Foundation, now closed to contributions, raised more than US\$2 million from donors around the world and funded about 60 grants that have allowed Rotary members to provide shelter, medical care, and other necessities.

The earthquake on 6 February 2023 killed more than 55,000 people and affected 15 million others across southern Turkey and northern Syria. Many clubs and districts have organized humanitarian initiatives guided by Rotarians in the affected areas. The three districts in Turkey worked together to implement projects totaling US\$10 million.

Immediately after the earthquake, Rotarians in Turkey set up three tent cities to provide temporary shelter for 2,000 families. The districts have since used US\$50,000 Disaster Response Grants coupled with other funds to establish two container cities while providing support for a third container city built by the local government in Ankara. Each container city includes units from large shipping containers for 110 families equipped with beds, mattresses, air conditioning units, water heaters, refrigerators, toilets, a bathtub, and kitchens. The Rotarians also built mobile kindergartens and prefabricated schools, a medical clinic, and a laundry facility in or near the container cities.

Refik Kutluer, president of the Rotary Club of Ankara International, says his club arranged for six children whose limbs were amputated from injuries suffered in the earthquake to receive prosthetic limbs at hospitals in the United States. The treatments were provided at no cost to the families. "All these children have returned home and are again able to walk," Kutluer says. "They continue to express their gratitude to Rotary saying that after the earthquake, they felt hopeless, but now they have been restored to life." The Ankara International club also provided a mobile science laboratory and classroom for Ata College, almost completely destroyed by the earthquake. The school lost 26 students, two teachers, and two staff members in the quake. Classes are being held in prefabricated buildings. Rotary and Rotaract members have also purchased essential equipment for a hospital in Antakya. Using two US\$50,000 grants, District 2430, Turkey, provided an ultrasound machine that hospital administrators requested as well as equipment to perform colonoscopies and endoscopies.

Rotarian support for the Rotary Foundation made this possible!
