

TOM HEINOLDArmy Corps. Of Engineers

Tom Heinold is currently leading the massive Illinois River Lock and Dam maintenance project for the U.S. Army Corps of Engineers Rock Island District, grew up in Massachusetts. His parents knew he was destined to be an engineer when they watched him dam up a stream in the backyard in order to have a place to swim with his brother. And an engineer he became.



He received a bachelor's degree in Aerospace Engineering from the United States Military Academy in West Point, New York, where he was commissioned second lieutenant. Heinold served in the Army and was on active duty for eight years with service in Germany, Korea and Kosovo. His last assignment as an active duty officer was for Rock Island District for the U.S. Army Corps of Engineers. "You get to pick

where you go after a tour in Korea and I just wanted to go to the Army Corps and I didn't care where." Heinold explained that he had never even heard of Rock Island but loved it as soon as he arrived and fell in love with the Corps of Engineers. After resigning his active commission in 2000, he took on a civilian position and remained in the Army as a reservist. In 2011, Heinold moved to the Operations Division and today serves as the Chief Operations Division Rock Island for the Army Corps. Heinold is very accustomed to great responsibility and service. In Kosovo, he was the engineer for the Joint Task Force Shining Hope. He was a part of team that designed a refugee camp for families who were forced out of their homeland during the conflict. As the engineer, Heinold built the roads, homes (tents), sanitation facilities and kitchen facilities for more than 20,000 refugees. The largest effort Heinold was a part of came after he was deployed to Iraq in 2008-09. His job as an engineer was to work himself out of a job. "It was my mission to come home," Heinold said. "I was in charge of designing facilities for the Iraqi Armed Forces so that they could equip their own forces and take the mission away from U.S. Forces, so that our men and women could come home." He also received a master's degree in engineering management from University of Missouri-Rolla and is a licensed Professional Engineer in the state of Illinois. During his 31 years of federal service, he has received multiple military and civilian achievement awards including a Legion of Merit, Bronze Star Medal, Meritorious Service Medal and the U.S. Army Superior Civilian Service Award. He has served as President for the Rock Island Post of the Society of American Military Engineers and as the Great Lakes Regional Vice President for the Society of American Military Engineers. He lives in Davenport, Iowa, with his wife, Eileen, and daughter, Meredith. Mr Heinold noted that the Corps of Engineers has a "multiple personality". They have a military function, building runways, barracks, messhalls, hangars, equipment facilities, etc.; a civil function, building, supervising, and upkeeping lakes, recreation areas, boat rams, and reservoirs; and a navagation function; building and maintaining locks and dams and maintaining the required 9 foot navagation channel depths on domestic navigable waterways. The Rock Island District of the U.S. Army Corps of Engineers administers federal water resource programs in a 78,000 square-mile area encompassing the eastern two-thirds of lowa, the northern half of Illinois and portions of southern Wisconsin and Minnesota, and the northeast corner of Missouri.

As chief of operations for the Rock Island District Mr. Heinold supervises 550 employees and their equipment including foresters, welders, tugboat pilots, engineers, and lock workers. Added to that are boats, heavy equipment, motor vehicles and the all the supplies and equipment needed to carry out the multiple functions of the corps. He advised that the 28 locks on the Mississippi between St. Paul and St. Louis are all 90 years or more in age. Funding for maintenance was cut off in the 1990's and needed work was stopped. Some of the lock gates failed and were temporarily replaced with bulkheads. Funding was restored in the past few years and catch-up work began. Heinold supervised the renovation of 8 locks on the Illinois River. Five were done in 2020 and 3 more in 2023. That covered a span from the Great Lakes to the confluence with the Mississippi River. Unfortunately, those repairs cause the shut down of navigation which is devastating to the navigation industry. Next on his "To Do" list is renovating the 28 locks on the Mississippi River between St. Paul and St. Louis, and in the case of 8 of the locks, doubling their size from 600 to 1,200-foot locks. Renovations will include replacing all the emptying and filling valves, gates, and mechanical mechanisms. Heinold noted that the money spent on locks has a benefit cost ratio much greater than 1 to 1. Keeping costs for transporting grain and multiple other materials at a minimum, while at the same time reducing semi traffic and fuel use on the highways. He noted river navigation is the cheapest and most efficient method to move goods, stating that one 15 barge tow is equivalent to 1,000 semis on the highway. In summing up Mr. Heinold said that maintenance is catching up, but it is still a race to renovate all the aging structures hopefully before a catastrophic failure creates a potential crisis in navigation and property damage. We thank Mr. Heinold for a very interesting and informative presentation.

Todd grew up in northern Illinois and served



four years in the U.S. Navy. He graduated from Southern Illinois University Edwardsville with a bachelor's degree in political science and a master's degree in public administration. He is a member of the International City/County Management Association (ICMA) and the Illinois City/County Management Association (ILCMA). Todd lives in Rock Island with his wife of 29 years, Leslie. They have two sons, one of whom is a student at Augustana College. In his free time, Todd enjoys golfing.
