Thurgood Brooks is a graduate of Rock Island High School where he was a student leader and star athlete in football and track. He received his bachelor's degree in

political science and history from Western Illinois University in 2015. In June of 2023 he was appointed West End Revitalization Coordinator for the City of Rock Island. In that capacity Thurgood lead a steering committee and 7 working groups of over 50 people to finalize a strategic plan and budget. He was charged with communicating with the community and donors and to track and oversee revitalization progress. He began by telling us that the project began in 2020 when the John Deere Foundation notified the City that they were interested in investing in Rock Island and asked for proposals. Among those presented was a proposal authored by King Center laying out the concept of "Revitalizing the West End". That proposal was selected and work began with establishing a steering committee to identify needs, make recommendations, and identify barriers that needed to be overcome. Just as things got started, the Covid pandemic hit and live meetings were shut down along with most everything else. To be deterred, meetings were held via Zoom and planning progressed. It was determined that the plan needed to address both the symptoms and the roots of problems that were identified. A vision was established and goals set. They focused their goals on five primary areas of impact: community engagement, assets and income, housing and land, economic vitality and infrastructure and visual appeal. It was also noted that in addition to support from the Deere Foundation and the City of Rock Island, the King Center has received a \$300,000 grant from the Quad-Cities Community Foundation to support the West End Revitalization effort. The steering committee has been meeting twice each month and revealed its threeyear plan on Friday, March 22. Mr. Brooks briefly outlined the plan's major components. The plan focuses on five impact areas: Community Engagement: This gives West End residents more opportunities to participate in local governments, budgets and future plans. **Personal Assets and Income**: The plan includes new financial and banking resources to help grow residents' wealth. Housing and Land: The plan will seek to create tenant organizations and paths to homeownership. Community Economic Vitality: This will include youth mentorships and job opportunities. **Infrastructure and Visual Appeal:** Sites like Franklin Field may be acquired and beautified to the community's desires. One of the first steps in the plan is to create a community development corporation for the West End. It's a non-profit organization that offers more flexibility than a city department like the MLK Center, such as a tax-exempt status. Goals of the plan include a community grocery store. The neighborhood is without one. Establishing pathways for the community to participate in city decision making; expanding affordable broadband access; enhancing the neighborhood's streetscapes; supporting and creating tenants associations; and expanding housing options. The vision is to make the West End a preferred place to live. Lofty goals, but with the dedication of more than 50 citizens working together as steering committee members, spokespersons such as Thurgood Brooks spreading the word to the commuinty, a solid commitment to succeed, and backing from the City, the King Center, the Deere Foundation, and the Quad Cities Community Foundation there is great hope that for all of Rock Island, this plan will succeed.

# **ROTARY FOUNDATION MINUTE**

The message this week is from Barry Rassin, Trustee Chair of TRF. In the current edition of Rotary (April 2024), Rotarian Rassin laments the failing health of our environment and what The Rotary Foundation can do about it.

"For many, the Bahamas is a place to escape colder climates, relax on white-sand beaches, and snorkel in clear, turquoise waters. For me, it's home. I grew up sailing on these waters and to this day, anytime I can, I am out on the water with family and friends. It's where my heart is. The environmental threats my country is facing are real. Our coral reefs, vital for biodiversity, are in danger due to warming seas and pollution. Hurricanes and tropical storms seem to get more intense with each passing year. Rising sea levels pose an existential threat to the Bahamas, eroding our beautiful coastlines as saltwater intrudes on our precious and limited freshwater resources. Rotary can be part of the solution.

As you know, protecting the environment is one of Rotary's areas of focus. Many clubs are active in their communities with projects such as beach and roadside cleanups. With The Rotary Foundation, you can increase your impact by pooling resources with clubs and districts around the world. Foundation grants let you put the generous contributions of your fellow Rotary members to work to make the world better.

The problems our environment faces seem overwhelming until you realize that many are fixable. There are so many ways to help through Rotary. Even if we don't lead a grant or volunteer on the project, we can all help protect the environment through our giving to the Foundation. Rotary can't save the planet all by itself. But as our progress in ending polio proves, Rotary's impact is great when we put our vision for a better world in motion, and just get started."


# THANKS TO THOSE WHO PARTICIPATED ...

The students brainstormed ideas throughout the fall and determined that our focus for our first project would be on serving needy members of our parish communities and the sick and elderly at Christmas. On Giving Tuesday, students held a "Stuff the Stocking" event wherein each class was challenged to stuff a stocking with monetary donations. Our EarlyAct students visited each classroom to speak about the project, and they were able to raise an impressive \$1,100! Jordan EarlyAct won a District 6420 \$100 prize after submitting this report for "Outstanding Achievement! Congratulations!







These donations were then used to purchase Christmas gifts for children and families in need at our affiliated parishes. Several members met at Target on a Sunday afternoon to shop and were able to provide gifts for 18 children and 2 adults. Some of our EarlyAct parents helped us wrap the gifts, and we were able to deliver them to the parishes in time for Christmas.



In addition to Christmas gifts, we also wanted to make sure the sick and homebound in our area received a Christmas greeting. We created handmade Christmas cards at two of our meetings which were delivered to Celebrate Senior Living and passed out to the residents.







In February, as we were contemplating our spring project, one of our beloved teachers at Jordan passed away unexpectedly. It was a shock to our school, but especially sad for our 6<sup>th</sup> graders who had her as their English teacher. Our EarlyAct students decided that our focus for spring would be on supporting our school and creating a lasting memorial in her honor. On May 14th, our EarlyAct students will be participating in a fundraising evening at Applebee's. The money raised from this event will be used to purchase perennial plants and annual flowers to be planted in a memorial garden and rosary walk that will be created at the school. It will also help us contribute to its upkeep throughout the summer months and beyond.

Later in May, our EarlyAct officers will visit the Rock Island Rotary to make a presentation about their projects this year. This will wrap up another successful and fulfilling year for our EarlyAct students at Jordan!
